# 13th Alabama Partisan Rangers

The 13th Battalion Alabama Partisan Rangers also known as the 13th Alabama Cavalry was organized about September 6,1862 with four Companies, "A" thru "D" and was commanded by Major William A. Hewlett. Company "E" was organized April 30,1863 and Company "F" was organized at the same time by transfers from other Companies. The men were recruited from the counties of Autauga, Butler, Mobile, Montgomery, and Walker. It was assigned to the Department of Mississippi and East Louisiana, and first served as scouts and pickets. With about 250 men, it fought at King's Creek under General Ruggles.

In June of 1863 the Battalion went through changes, Company A was transferred in early June to the 22nd Tennessee Cavalry Regiment, as Company "H", only to be transferred back later that month as Company "L", as the 13th Battalion and 15th Battalion (Partisan Rangers) were merged together to form the 56th Alabama Cavalry Regiment Partisan Rangers.

The 56th Alabama Cavalry Regiment was brigaded under General Samuel W. Ferguson and sent to north Georgia. It served on the flank of the army during the Dalton-Atlanta campaign, and it saw arduous duty. The regiment moved with General John Bell Hood to Tennessee, then it turned and harassed Union General William T. Sherman. It was in the trenches of Savannah and operated

near Augusta. It moved into the Carolinas and was surrendered at Greensboro, 26 April 1865, about 150 strong.

Lt. Colonel William Alexander Hewlett moved to Texas after the war and died in 1904 and is buried in the Necessity Cemetery, Stephens County, Texas.

CHAPTER XVI

STATE SENATORS

The first Senator from Walker county was William A. He was first elected Judge of the County Court, but owing to the establishment of the Probate system, he served but a short time. He opened a law office in Jasper. In 1853 he was elected to the Senate from the District composed of the counties of Lawrence, Winston and Walker, and served for four years.

Judge Hewlett was a nephew of Maj. David Hubbard, was a young man of fine personal appearance, very preposessing in conversation, and if he had studied his cases a little better would have made a very fine lawyer. He was very kind and liberal as a friend and a citizen—always ready to give or receive favors, and it made but little difference with him whether he was granting or receiving them. He took a good stand in the Senate, was universally popular—did not often occupy the floor, but whenever he did he commanded attention. Judge Hewlett was a Democrat of the Old School. In fact, he was so far in advance of his party as to advocate State Aid to works of internal improvements, and often predicted thro that instrumentality the development of mineral wealth now going on in the country, and which bids fair to make Walker county at no very distant day one of the most important counties in the State. In 1860 as supported the Breckenridge wing of the Democratic party. I think his Battalion was finally consolidated with another and formed into a Regiment, and Major Hewlett was promoted to the rank of Lieut. Colonel.

After the war the Judge moved to Texas,—since then I have heard but little from him.

NEED TO KNOW: Camping is allowed, self-contained RVs are welcome...there is no water or electricity available. Food and Drink trucks are scheduled to be there but, they also say "Fend for Yourself", so 'Be Prepared.' BURN BAN is in effect, no open fires. Propane

stoves are allowed. Your ATV is welcome and must be operated in a 'Safe' manner from point 'A' to point 'B', NO riding around the countryside. Rule #1 – You Pack It In – You Pack It Out! So, bring trash bags, let's be respectful of our Southern Brothers. And most importantly there will be a Sunday morning Church Service.

As you enter Proctor, Texas, look for FM 1476. Turn south on FM 1476 and drive approximately 1.5 miles looking for a gate on the left side of the road. Area will be marked with flags.
